The Board of Supervisors of Winston County, Mississippi will receive bids for the construction of the Zion Ridge Road Bridge Project, MDOT Project No. CHBP-0080-00(33) 108130-70200 and State Aid Project No. LSBP-80(14), no later than 10:00 A.M., Local Time, September 20 , 2019, at the Winston County Courthouse located at 115 South Court Ave., Louisville, MS 39339. All bids so received will be publicly opened and read aloud.

The work shall consist essentially of the following items:

Construction of a box bridge and temporary gravel approaches, and other related items of work required to complete the project as shown and specified in the Construction Plans and Contract Documents.

The above general outline of features of the work does not in any way limit the responsibility of the contractor to perform all work and furnish all labor, equipment and materials required by the specifications and the drawings referred to therein.

The attention of bidders is directed to the Contract Provisions governing selection and employment of labor. Minimum wage rates for Federal-Aid projects have been predetermined by the Secretary of Labor and are subject to Public Law 87-581 Work Hours Act of 1962, as set forth in the Contract Provisions.

Each bid shall be accompanied by a Cashier's check, Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the Winston County Board of Supervisors as bid security. Bidders shall also submit a current financial statement, if requested by the County. The successful bidder will be required to furnish a Performance Bond and a Payment bond each in the amount of one hundred percent (100%) of the contract amount. NO STRIPPED PROPOSALS WILL BE ACCEPTED.

The proposal and contract documents in its entirety shall be submitted in a sealed envelope and deposited with the Chancery Clerk, 115 South Court Avenue, Louisville, Mississippi prior to the hour and date above designated.
