

# **MDOT, MRBA and MAPA 2022 Storm Water Training**

Thompson Engineering will be performing the Storm Water Training at specific locations throughout the state in January, February, March, April and May of 2022. For those persons that were certified in 2017, you will need to become re-certified because the certification is good for five (5) years.

There is a Memorandum of Understanding between MDOT, MRBA, MAPA and Thompson Engineering that specifies certain requirements that Thompson Engineering must follow regarding the number of attendees per class from MDOT, the construction industry and then from others. We will adhere to the following requirements:

- MDOT will be allocated 17 slots per class
- The Construction Industry will be allocated 18 slots per class
- If MDOT does not utilize their allocated slots for a particular class, the Construction Industry will have first chance at the available slots. Vice versa if the Construction Industry does not utilize their allocated slots.
- If MDOT and the Construction Industry do not use all of the available slots for a class, these slots will be made available to others such as State Aid staff, County Engineers and consultants.

**The actual number of persons assigned to a training class will be determined based upon the size of the training room at each District Office and any COVID-19 considerations at the time of each training class.**

The training classes will be held at the various District Office Complexes. The classes will begin at 8am and they will end before 5pm. Lunch will be provided for the attendees. As in the past, there is a test at the end of the class that the attendees must pass in order to be certified.

**The following is the training schedule for each MDOT District:**

Week of January 24th	District VI	(Hattiesburg))
Week of February 21st	District VII	(McComb)
Week of March 7th	District III	(Yazoo City)
Week of March 21st	District V	(Newton)
Week of April 18th	District II	(Batesville)
Week of May 9th	District I	(Tupelo)

We will begin filling the sessions based upon the slots available and in accordance with the requirements stated above. We recommend that you register to attend a class at your desired District at the earliest possible moment. This will increase your chances of being assigned to a class at a specific District Office.

**Construction Industry Attendees:** Please contact Sherena Sarullo by E-mail to register your employees. We will make every effort to assign your employees to the District that you request, but we can not guarantee it due to the allocation of slots. You will need to be prepared to furnish Sherena with the names of your employees that will attend a class.

**Others:** Please contact Sherena Sarullo at 601-899-9252 to be placed on a waiting list at each District. If there are available slots at the District that you request, we will use the waiting list to fill any available slots. If there are no available slots at the requested District, we will advise you where there are available slots for your consideration.

**Training Fee:** \$250.00 per attendee (Please note that once you are assigned a slot, you are responsible for that slot. If someone can't attend a class, you may substitute someone to fill the slot. Please notify Sherena Sarullo of any substitutions as soon as possible prior to the class. If the substitution is made the day of the class, you must advise the person at the registration desk of the substitution. Refunds will only be made if you notify Sherena 7 days in advance of the assigned class. Due to the potential limited number of slots at a District Office, if you don't attend the assigned class and you don't have a substitute, you will have to pay another training fee for the person to be certified at a later date.)
